1. Important Policy Decisions/Major Achievements during the Month:-

I. Winter Session 2022:-

1. The Winter Session, 2022 of Parliament which commenced on Wednesday, 7th December, 2022 was adjourned sine die on Friday, the 23rd December, 2022. The Session provided 13 sitting spread over a period of 17 day.
2. The Session, which was originally scheduled to have 17 sittings from 7th December, 2022 to 29th of December, 2022, was curtailed due to completion of essential Government Business and consensus in respective BAC,s of Houses of Parliament.
3. During the Winter Session, 2022, 9 Bills were passed by both the Houses of Parliament.

VI. Meeting of Cabinet Committee on Parliamentary Affairs

- i. The 10th Session of 17th Lok Sabha and 258th Session of Rajya Sabha (Winter Session, 2022) which were adjourned sine-die on Friday, the 23rd of December, 2022 be prorogued.
- ii. Ratified cases of Government's Stand on Private Members' Bills and Resolutions for being "Member may be requested to withdraw the Bill/Resolution failing which it may be opposed/to be opposed" approved by the Hon'ble Minister of Parliamentary Affairs under the power delegated to him through Cabinet Note No. 08/2022.

VII Prorogation of Both Houses.

Lok Sabha and Rajya Sabha which commenced their 10th Session and 258th Session respectively on the 7th December, 2022, were prorogued by the Hon'ble President on the 24th December, 2022.

• Implementation of Assurances in Parliament

During the month of December, 2022, 30 Assurances were culled out from Lok Sabha proceeding and 35 Assurances were culled out from Rajya Sabha proceedings.

During the Month of December, 2022, 268 Implementation Reports were laid in Lok Sabha and 122(18 Parts) Implementation reports were laid in Rajya Sabha.

- **National e-Vidhan Application (NeVA)**

During the month of December , 2022 the following activities were undertaken on NeVA front:

1. Visit by officials from Meghalaya Assembly

4 officials from Meghalaya Assembly visited CPMU NeVA cell at Parliament House Annexe, New Delhi from 05th Dec, 2022 to 07th Dec, 2022. In the visit the officials were given training in Digital archives and Reporter module alongwith resolution of queries related to other modules of NeVA platform.
