Interested bidders may deposit EMD at the earliest so that they may be permitted to submit their bids online through GeM.
- 4. The sale against this enquiry shall be governed by the following Terms & Conditions:
 - a) Interested Parties may submit EMD in the proforma annexed with the tender document alongwith other relevant papers like copy of PAN Card, GST Registration of firm, address proof etc.
 - b) The disposal of the items in one lot shall be strictly on "AS IS WHERE IS BASIS" and no guarantee of certificate of its worthiness or quality will be given by this Ministry. - c) If the highest successful bidder accepted by the competent authority in this Ministry fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited,
