E-AUCTION NOTICE

E-Auction of two Cars (1) Maruti Ciaz VXI DL-1C T-3347 Model 2015, Petrol, with RC, Tax: OTT and (2) Maruti Ciaz VXI DL-9C AP-8888 Model 2016, Petrol, with RC, Tax: OTT belonging to this Ministry will be held on Friday, the 31st October, 2025 at 2.30 P.M. Both the vehicles are parked in underground parking of Parliament Library Building and can be inspected on 28th and 29th October, 2025 after prior appointment through telephone No.011-23034743, 23034899 (Entry through gate opposite Gurudwara Rakabganj). Each vehicle will be auctioned separately.

Terms & conditions: Both the cars will be auctioned on “As is Where is Basis” and will be lifted by the highest bidder. The refundable security deposit of Rs.30,000/- for each vehicle in the form of DD/NEFT/RTGS in favour of M/s. Accurate Auctioneers, payable at New Delhi to be deposited by each bidder before the start of the auction. Acceptance of highest bid will be subject to the approval of competent authority in the Ministry of Parliamentary Affairs. Validity of bid will be for 45 days. Bidder will provide with his/ her identity proof and apply online for transfer papers for transfer of the vehicle and have to complete the transfer formalities in respective name within 30 days. Security deposit of successful bidder will be refunded after the completion of transfer proceedings. Payment of highest bid amount will have to be made within 48 hours after approval, otherwise penalty of Rs.500/- per day will be charged. Auctioned items will have to be removed within a week after depositing the highest bid value.
