Subject:- Disposal of Obsolete & unserviceable e-waste like Photocopy machines, Computers, TV & furniture etc in one lot.

Fresh Quotations are invited in single bid systems from reputed firms for disposal of the condemned Obsolete & unserviceable e-waste like, Photocopy machines, Computers, TV & furniture etc on 'AS IS WHERE IS' basis, as per list enclosed.

2 The Tender Document can be downloaded from GeM portal. The bid documents may be submitted along with EMD amounting to Rs.2000/ (Rupees two thousands only) in favour of Pay and Accounts Officer, Cabinet Affairs, New Delhi. The quotation should reach on or before **23.08.2022 by 14:00Hrs**. The quotations received after the stipulated date and time will not be entertained. The quotations will be opened on 24.8.2022 at 11:00 Hrs in Room No. 94, Parliament House, New Delhi.

3. The bids should be submitted in proforma annexed with this tender document notice. No physical papers except EMD (in original) for Rs. 2000/- (Rupees two thousands only) to be submitted in favour of 'Pay and Accounts Officer, Cabinet Affairs, New Delhi' in the form of DD/Pay Order/Banker's Cheque.

4. The sale against this enquiry shall be governed by the following Terms & Conditions:-

- a. Interested Parties may submit their highest prices for obsolete e-waste items in proforma annexed with the tender document alongwith other relevant documents (Copy of PAN Card, GST Registration of firm, Address proof)
- b. The disposal of the e-waste items shall be strictly on 'AS IS WHERE IS BASIS' and no guarantee of certificate of its worthiness or quality will be given by this Ministry. The parties may inspect items physically between 2.30 PM to 4.30 PM on 17.08.2022 at Jam Nagar House, Barricks and Parliament House, New Delhi with prior appointment (Tel. No. 011-23034755).
- c. If the highest tenderer/successful tenderer accepted by the competent authority in this Ministry fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited, In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.
- d. The successful bidder(s) will be required to deposit the total sale amount by means of Demand Draft/Pay Order/Banker's Cheque in favour of 'Pay and Accounts Officer, Cabinet Affairs, New Delhi' within three working days of award of the contract.
- e. Earnest Money Deposit of the bidders who fail to honor the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Ministry. EMD amount will not be adjusted in the sale amount. EMD of successful bidder

- (s) shall be released only after successful completion of the sale process. Unsuccessful bidder may collect their EMD immediately after completion of sale process.
- f. The delivery of the sold e-waste items will be arranged only after successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card in case of individual and Registration Certificate in case of firms etc.)
- g. The sold e-waste items will be removed by the successful bidder(s) within 48 hours of depositing the money at their own expenses. No assistance/transportation will be provided by the Department. Permission to take out the e-waste items from Parliament House premises will not be allowed on holidays, (Saturdays, Sandays or any other).
- h. EMD of the firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of Competent Authority shall be final in this regard.
- j This Ministry reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
- K The bidder is required to reveal his full name of authorized signatory of the firms/name of the father, full postal address telephone numbers & mobile numbers.
- l Disputes, if any, shall be subject to jurisdiction in the court of Delhi only.
- m. If the highest quoting firms fails to honour the bid the contract will be cancelled & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided he is prepared to accept the prices offered by the H-1 party. In case of any dispute, decision of Ministry shall be final.
- n. The tendering form should be signed in ink by the authorized signatory.
- o. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequence or loss thereof.
- p. Quotation should be offered in proforma prescribed as given Annexure.
