During the month of February, 2024 the following activities were undertaken on NeVA front:

The proceedings of the 5th session of the 12th Manipur Legislative Assembly, starting from 27th February were conducted through NeVA. The assembly became the 13th legislature in the nation to embrace NeVA, transforming itself into a digital house.

(2) Assam became the 23rd legislature in the country to sign MoU with MoPA to adopt NeVA

A tripartite MoU was signed between Govt. of Assam, Assam Legislative Assembly and Ministry of Parliamentary Affairs in the presence of Secretary, MoPA on 22nd February, 2024 to transform Assam Legislative Assembly into a digital house by embracing NeVA.

(3) Live house sessions held through NeVA
