- 1. Important Policy Decisions/Major Achievements during the Month:-
  - A. Important Legislative Business

#### I. <u>Meeting of the Cabinet</u>

- 1. The Cabinet in its meeting held on 05.06.2024, decided to advise the President to dissolve the Seventeenth Lok Sabha.
- 2. The Cabinet in its meeting held on  $10^{th}$  June, 2024, decided the following:-
- i. Lok Sabha be convened on 24.06.2024, and the Rajya Sabha be convened on 27.06.2024 and subject to exigencies of Government Business, both the Houses of Parliament may conclude their Session on 03.07.2024.
- ii. The election of the Speaker be held on 26.06.2024; and
- iii. The President be requested to address both the Houses of Parliament assembled together in the Lok Sabha Chamber, Parliament House at 11.00 a.m. on 27.06.2024.

#### II. <u>Dissolution of Seventeenth Lok Sabha</u>

The President approved the decision of the Cabinet to dissolve  $17^{th}$  Lok Sabha on 05.06.2024, which was conveyed to Lok Sabha Secretariat and duly notified on the same day.

III. Appointment of Speaker, pro-tem and persons for oath/affirmation of new elected Members of Eighteenth Lok Sabha

The President appointed Sh. Bhartruhari Mahtab, as Speaker, *pro-tem* and Sh. Suresh Kodikunil, Sh. Thalikkottai Rajuthevar Baalu, Shri Radha Mohan Singh, Shri Faggan Singh Kulaste and Sh. Sudip Bandyopadhyay as persons before any of whom the new members may make and subscribe oath or affirmation. Sh. Bhartruhari Mahtab was administered oath/affirmation on 24.06.2024 at Rashtrapati Bhawan.

## I V <u>First Session of 18<sup>th</sup> Lok Sabha and 249<sup>th</sup> Session of Rajya Sabha commenced.</u>

The First Session of  $18^{th}$  Lok Sabha commenced on  $24^{th}$  June, 2024 and the  $264^{th}$  Session of Rajya Sabha commenced on  $27^{th}$  June, 2024.

#### V. **Oath or Affirmation.**

The newly elected Members of  $18^{th}$  Lok Sabha took Oath or Affirmation on  $24^{th}$ ,  $25^{th}$  and  $26^{th}$  June, 2024.

#### VI. **Election of Speaker.**

Election of Speaker, Lok Sabha was held on 26<sup>th</sup> June, 2024.

#### VII. **Delivery of President's Address.**

The President of India addressed the two Houses of Parliament assembled together in Lok Sabha Chamber of Parliament House on 27.06.2024.

#### **B.** Implementation of Assurances in Parliament

At the end of the month of June, 2024, 566 Assurances of Lok Sabha and 662 Assurances of Rajya Sabha were pending. During the month, 17 Assurances were added at the instance of the Committee on Government Assurances, Lok Sabha while 01 Assurance was added at the instance of Committee on Government Assurances, Rajya Sabha..

The 14<sup>th</sup> meeting of empowered committee of NeVA was held under the chairmanship of Secretary, MPA on 5 <sup>th</sup> June, 2024 to approve the DPR for implementation of NeVA Project in Rajasthan Legislative Assembly. The Committee granted sanction for the NeVA Project in Rajasthan Legislative Assembly with a Project outlay of Rs. 12,61,60,250/-.
