Subject: - Monthly Summary for the month of February, 2021 of Ministry of Parliamentary Affairs.

1. LEGISLATIVE BUSINESS IN PARLIAMENT

Ministry of Parliamentary Affairs serves as an important link between the two Houses of Parliament on the one hand and the Government on the other in respect of Government Business in Parliament.

 253^{rd} Session of Rajya Sabha and 5^{th} Session of 17^{th} Lok Sabha adjourned for recess on 12^{th} February and 13^{th} February, 2021 respectively to reassemble on Monday, the 8^{th} March 2021.

A summary of Legislative Business transacted during the month is as following –

2. IMPLEMENTATION OF ASSURANCES IN PARLIAMENT

This Ministry is the co-ordinating agency to ensure that the Ministries fulfil their assurances, given by the concerned Ministers while replying to questions or supplementary thereon or during discussion on Bills, Resolutions, Motions in Parliament, in time. The Ministry extracts from the daily proceedings of both the Houses, assurances given by Ministers and forward the same to concerned Ministries for necessary action. The Implementation Reports received from administrative ministries in fulfilment of an assurance are laid on the Table of the respective Houses.

From 1956 to January, 2021 a total of 96645 Assurances were culled out in Lok Sabha and 56809 Assurances were culled out in Rajya Sabha. Out of these 1733 Assurances of Lok Sabha and 799 Assurances of Rajya Sabha are pending.

During the month of February, 2021, 42 Assurances were culled out from Lok Sabha proceedings and 35 Assurances were culled out from Rajya Sabha proceedings.

During the month of February, 2021, 390 Implementation Reports were laid in Lok Sabha and 140 (9 Parts) Implementation Reports were laid in Rajya Sabha

3. FUNCTIONING OF CONSULTATIVE COMMITTEES

Informal Consultative Committees were constituted for various Ministries/Departments of Government of India, first time in the year 1954 to provide opportunities to Members of Parliament to have some glimpse into the working of the Government. Nature of these Committees is advisory. At present 37 Consultative Committees are functioning for various Ministries.

In the month of February 2021, -

- A. Three meetings of Consultative Committees have been held.
- B. Names of seven Members of Parliament have been deleted from various Consultative Committees after their Death/Retirement/Resignation.
- C. Eight Members of Parliament have been nominated on various Committee/Boards/Commission by the Government.

The above details are placed in Annexure – II.

4. DIGITAL GOVERNANCE - IMPLEMENTATION OF e-OFFICE

This Ministry was selected for implementation of e-Office Mission Mode Project (MMP) by Department of Administrative Reforms and PublicGrievances (DARPG) in the second phase. From October, 2013 after digitization of physical files, sections of the Ministry were brought under e-office.

All matters relating to leave of employees, service, billing etc are being done through electronic means. This has helped the Ministry to be more efficient, lesser usage of paper, rule based file routing, quick search and retrieval of files and office orders. DARPG has awarded this Ministry for commendable performance shown in implementation of e-office.

In the month of February, 2021, most of the work was done electronically and 1963 electronic files were moved.

5. MOTIVATING YOUTH THROUGH YOUTH PARLIAMENT SCHEMES

During the month of February, 2021, Registrations of 274 schools for participating in National Youth Parliament Schemes were reviewd and out of them, registrations of 71 schools were approved.

6. <u>NATIONAL e-VIDHAN APPLICATION (NeVA) : ONE NATION – ONE APPLIC ATION</u>

NeVa is a Mission Mode Project under the Digital India Programme. Its mission is to make the legislatures of all the States/UTs paper less, streamline all the processes for information exchange with the different State Government Departments and to publish the allowed contents on the public portal in real time. The NeVA works on both web-based and application based (both Android and IOS) platform, in a format consistent across National and State legislatures.

Various States have adopted the NeVA, a project for digital legislatures and have started working on it. With the sole objective of knowledge transfer for capacity building of the officials of the legislatures, CPMU, NeVA has started in house training/workshop in association with the concerned Assembly/Council/State NIC.

Upto the month of Febuary, 2021 Memorandum of Understanding (MoU) for implementation of NeVA has been signed with 15 States (16 Houses) which includes Bihar (Assembly and Council), Punjab, Odisha, Meghalaya, Manipur, Gujarat, Arunachal Pradesh, Nagaland, Tripura, Chattisgarh, Sikkim, Puducherry, Himachal Pradesh, Tamil Nadu and Haryana. Detailed Project Reports (DPR) for the sanction of NeVA project have been submitted by 7 States (8 Houses) Punjab, Odisha, Bihar (Assmebly and Council), Nagaland, Manipur, Sikkim and Arunachal Pradesh first instalment for implementation of NeVA has been paid to Punjab, Odisha, Bihar (Assmebly and Council), Nagaland and Manipur.

In the month of February, 2021 –

- i) A NeVA workshop was organised by CPMU NeVA team at the Odisha Assembly on 15-16th Feb 2020 which was inaugurated by Dr Surjya Narayana Patro, Hon'ble Speaker and was attended by more than 100 officials of Odisha Assembly & Government. The workshop helped Odisha Legislative Assembly in tabling their financial budget paperless. Due to this the budget in Odisha Assembly was presented in complete electronic form through National e-Vidhan Application (NeVA), making Odisha a model state. Hon'ble Minister Shri Niranjan Pujari delivered the "Peoples Budget Odisha" speech from iPad while the documents were available as Ebook. In this way it is marked as a historic day for Digital Legislatures initiative National eVidhan Application (NeVA), as Odisha has become first state to present Rs 1.7 lakh crore annual state budget 2021-22 digitally through NeVA.
- ii) A tripartite MoU for implementation of NeVA in Sikkim Assembly has been signed by the Ministry of Parliamentary Affairs with the Government of Sikkim and the State Legislative Assembly. A DPR has been received from Sikkim for implementation of NeVA and is being scrutinized.
- iii) DPR has also been received from Arunachal Pradesh Assembly which is under consideration.
- iv) Dr. Rajendra S. Shukla, Secretary, Ministry of Parliamentary Affairs(MoPA) along with Dr. Satya Prakash, Joint Secretary held

review meetings on progress of implementation of NeVA in Tamil Nadu with Sh. Rajeev Ranjan, Chief Secretary, Shri Hans Raj, ACS(IT), Sh. K Sriniwasan, Secretary (Assembly) and other officials on 18th and 19th February, 2021.

- v) Uttar Pradesh presented 'paperless' Budget through National eVidhan Application (NeVA) on 28th February, 2021 and as per the statement of the Hon'ble Speaker, UP Assembly, everything including the agenda of the House, questions and answers will become paperless through NeVA.
- vi) Secretary, MoPA along with the Joint Secretary visited Haryana Assembly and signed the tripartite MoU with Haryana Government and Haryana State Assembly on 25th February, 2021 in the August presence of Hon'ble Speaker, Haryana Assembly. Secretary, MoPA also had a review and preparatory meeting on the subject with Chief Secretary, Haryana where all stake holders of the project were present.
- vii) On 26th February, Secretary, MoPA alongwith the Joint Secretary had a review meeting with Chief Secretary and all other stakeholders of the project in the state to make the proceedings of the Punjab Vidhan Sabha paperless under 'Digital India' by using NeVA. Chief Secretary, Punjab conveyed that the State Government has decided to conduct the proceedings of Budget Session digitally. Prominent amongst others, who were present in the meeting included; Mr. Anirudh Tewari, Additional Chief Secretary Administrative Reforms, Mr. Alok Shekhar, Principal Secretary, Parliamentary Affairs and Mrs. Shashi Lakhanpal Mishra, Secretary, Punjab Vidhan Sabha.

7. SOCIAL MEDIA

Social Media is an emerging platform for information sharing and receiving feedback. Ministry of Parliamentary Affairs has taken the initiative of getting its presence registered on various social media platforms.

With a total of 1744 tweets, the number of twitter followers for the Ministry's handle https://twitter.com/mpa_india touched 4481 and that of Facebook's followers became 37099.
